### • BITCHES IN SEASON ARE NOT ALLOWED ON THE TEST GROUNDS

- Entry fees for bitches that come into season after the closing date will be refunded (minus \$3.00 per day administration fee) if a veterinarian's certificate is presented to the Test Secretary prior to the start of judging.
- A limited number of dogs may be entered the day of the test if space and birds are available. Additional fee of \$10.00 for dogs entered after closing.
- The training session will be on Sunday, April 14, 2013 at 2 PM to dusk. This is an opportunity to familiarize you and your dog with the grounds. You may bring Dokkens and/or bumpers for training.
- The WC will start at 9 AM, land first. Water tests to follow for all dogs passing land tests.
- The WCX land will start after completion of the WC.

## NOTICE TO EXHIBITORS

### **SAFETY, BEHAVIOR and LIABILITY**

**The safety of the dog** is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport and that their dogs are accustomed to gunshot and live birds.

**It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. IWSCA and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children or spectators.

**IWSCA** reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the IWSCA or any official thereof.

**All dogs must be on leash** at all times when on trial grounds except the dog being tested. No pinch/prong, electric or special training collars are allowed on the show grounds.

**Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the grounds.

### **REFUNDS**

**No entry fee** will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee.

**Bitches in season** are not permitted to compete in the training session or the hunt test. As such, the club will refund all but \$3 per day of the entry fee paid for bitches unable to compete for this reason upon presentation of a veterinarian certificate. This certificate must be presented to the Trial Secretary prior to the start of judging.

**Handlers and dogs may arrive** any time prior to start of the hunt test.

**Judges are not required** to wait for dogs. The Owner of dogs is solely responsible for having it ready when their number is called. The Club has no responsibility for providing service through a public address system or runners for the purpose of calling or locating dogs that are not brought to the line when required.
